# 2021 Commercial Fishing and Seafood Processing Facts

Alaska's commercial fishing sector is a major contributor to employment and wages in Washington. The Alaska fishing industry employs thousands of individuals from U.S. states, who earn millions of dollars in wages, and produces billions of pounds of seafood for the US and the world. Commercial fishing permit holders represent small and family-owned business, supporting dozens of other service businesses such as hardware and marine suppliers, fuel, accountants, air and water travel and shipping, boat builders, restaurants, scientists, and administrators.

Virtually every business in the greater Seattle area benefits from commercial fishing dollars.

Statistics are not readily available for Alaska seafood processing jobs and wages paid to Washington residents. The following numbers are for harvesting (fishing) only:

### **Key Statistics from 2021:**

- Washington residents who fished an AK commercial fishing permit: 1,304<sup>1</sup>
- Washington resident AK commercial crewmember license holders: 3,863<sup>2</sup>
- Washington resident permit holders who fished plus crew: 5,167<sup>1,2</sup>
- Alaska commercial fishing vessels registered to Washington owners: 1,521<sup>3</sup>
- Alaska and offshore federal fisheries ex-vessel earnings by Washington-based permit holders:
   \$678.5 million<sup>1</sup>
- Estimated AK and offshore federal fisheries harvest by Washington-based permit holders: 3.6
   billion pounds <sup>1</sup>
